Learning and growing

It is certainly an interesting and exciting time in the education sector, as we contemplate what learnings we can take forward from the Covid-19 remote schooling experience.

Our <u>recent parent survey</u> showed a variety of experiences, but the common denominator through it all was how the pandemic highlighted the need for true family engagement. Those schools already actively engaged with their families found it much easier to support their students to learn from home.

Many families reported that their schools were engaging with them for the first time, with mixed results. It's a reminder of what ACSSO has been saying: that it is much easier to commence family engagement strategies in more peaceful circumstances!

Another common theme was the highlighting of ongoing inequity within and between our schools, particularly in terms of devices and connectivity.

These are all issues we will continue to discuss with the Australian Department of Education, Skills and Employment, and other stakeholders in the sector.

Welcome support for positive mental health

Mental health in schools has taken a higher priority with governments at the moment, as well it should. We have recently attended several conferences and stakeholder consultations addressing all areas of mental health and will continue to share the learning from those sessions.

We are keen to have our families' voices heard in discussions pertaining to students' improved mental health, and are pleased by recent announcements committing extra funding and resources for schools to support the positive mental health and wellbeing of students.
